21 **INTRODUCTION**

22 Plaintiff Robert Jacobsen respectfully asks the Court to set a status conference at its earliest
23 convenience.

24 **FACTS AND ARGUMENT**

25 Pleadings in this case closed on Monday, March 2, 2009 when Jacobsen filed his answer to
26 Defendants Matthew Katzer and KAMIND Associates, Inc.'s counterclaim. An appeal is pending
27 relating to the denial of Jacobsen's motion for preliminary injunction, but aside from deadlines

1 associated with the appeal, no further deadlines have been set in this litigation.

2 Jacobsen seeks to move the case forward. He believes it would be productive to have a
3 scheduling conference. He respectfully requests the Court set a status conference, with a report,
4 due a week before the status conference, from the parties to address scheduling. Among the items
5 for discussion are the Rule 26(f) conference, updates to Rule 26(a) disclosures, timing of the Rule
6 16 conference, and the appeal. The status report prior to the status conference would allow the
7 parties to identify any other scheduling issues that the parties and the Court need to be aware of.

8 Jacobsen contacted Defendants for their position on this motion. Defendants also seek a
9 status conference to set deadlines for litigation activities.

10 **CONCLUSION**

11 For these reasons, Jacobsen respectfully asks the Court to schedule a status conference.
